Here's my compilation of our comments during last week's teleconference call, plus a scan of the "goat herder discussion" from the book. Sometimes when I'm doing these I include sample dialogue because it's simpler than explaining what needs to be said -- the filmmakers can rewrite it to suit their needs. But in this case I was hesitant to rewrite what Luttrell believes was said to the best of his memory, so I opted for the explanation rather than suggested dialogue. Don't know if this was the better choice or not.

No pride of authorship here, I welcome comments, corrections, additions, and other suggestions.

There's some kind of meeting taking place at Film 44 on June 12 or 13, with Pete, Sara, Harry Humphries, Louis Freedman, Bob, and Chad, with me maybe being able to call in. Neither Bob nor I understand what the purpose of the meeting is, but I'm assured that it's not to discuss the script. The filmmakers are aware that we discussed the script and that notes will be forthcoming very soon. I expect that we will have a face-to-face discussion with Pete on our notes, but don't know when.

Pg 4 - No mention of bleeding in the book. Pg 159: "...the day they pinned the Trident on my chest." (b) (5)

Pg 6 - Dietz has demon sleeve tattoos. In a photo of him shirtless in the book, he has no tattoos at all. (b) (5)

Banter and behavior:

Pg 16 – CHOW HALL BAGRAM: 2-page scene in which the four conduct fly-catching competition while discussing Dietz's concern with his wife's home improvement efforts.

Pg 18 – CHOPPER PAD BAGRAM: 2-page scene in which the four discuss Dietz's apparently angry telephone conversation with his wife.

Pg 24 – HINDU KUSH – NIGHT VISION GREEN: Luttrell and Murphy throw rocks at each other.

Pg 28 – HINDU KUSH: Luttrell criticizes Murphy's hide and calls him a jackass.

Pg 29 – HINDU KUSH: Luttrell and Murphy have a conversation about powerbars, then exchange taunts ("Blow me," "Fag") and farts.

Pg 31 – HINDO KUSH: Dietz points his sidearm's laser targeting dot on Luttrell's head.

What's the source? These are not mentioned in the book. There's plenty of banter, but it's brief and typical.

Pg 20 - CH-47 insertion: in the script, it's dusk, the rope gets stuck, the aircraft bucks violently," the crew chief drops the rope, and the SEALs are very unhappy that they have to hide it "That helo crew was supposed to have taken the rope with them." In the book, it's pitch dark, the rope was "positioned expertly," the SEALs egress without any problem, and no mention is made about the rope being dropped or not.

Pg 42 and elsewhere – The goat herder encounter.

While maximizing historical authenticity is our mandate, we share responsibility for the reputations of the four SEALs and to their families' memories of them. Some key considerations:

(Question: the only reference in the book to comms during this period are Dietz's unsuccessful attempts to reach anyone. Is the rationale behind the extended fictional dialogue in the script between Murphy and the J-BAD and Bagram TOCs to demonstrate the efforts the team made to reach higher HQ?)

Luttrell's refers to Axelson as their "resident academic." He's quoted in the book as saying "I think we should kill them, because we can't let them go." We think in direction if not also in dialogue that Axelson is troubled by his own recommendation, but is trying to be analytical.

(Note: the words "soft compromise" are not found in the book.)

Dietz's "I really don't give a shit," can likewise be interpreted as a disinclination to recommend either of two terrible choices: killing the goat herders or releasing them and thereby placing the SEALs in even greater danger.

In the book Luttrell makes it clear that he's in favor of killing the goat herders, yet he tells Murphy, "We gotta let 'em go." (b) (5)

SFC Carl,

Lone Survivor is about Luttrell and three members of his SEAL platoon's participation in Operation Red Wing which took place in Afghanistan 28 June 2005. The SEALs were on a special reconnaissance mission and got into a firefight with about 50 Taliban. The other three members of the team were killed. SEAL LT Michael Murphy received the Medal of Honor for his actions in the firefight. Luttrell was wounded but survived with the assistance of an Afghan goatherd.

In addition to the SEALs on the special recon team that got killed, a QRF of about 16 other SEALs and members of the 160th SOAR were killed when their MH-47 was shot down.

Below is a more detailed summary of the battle.

Is the focus of the Dateline piece the battle or the making of the movie?

There are no talking points. Both USSOCOM and Naval Special Warfare Command have been working with Peter Berg, the movie producer for three or four years, on this project.

Our only advice to the chaplain would be very basic public affairs guidance to talk about the events about which he has personal knowledge and nothing else, and to be sensitive about any propriety interests of the surviving families.

The SEAL team involved was not a classified unit and any classification associated with the mission has long been declassified.

#### Operation Redwing

On June 28, 2005, deep behind enemy lines east of Asadabad in the Hindu Kush of Afghanistan, a very committed four-man Navy SEAL team was conducting a reconnaissance mission at the unforgiving altitude of approximately 10,000 feet. The SEALs, Lt. Michael Murphy, Gunner's Mate 2nd Class (SEAL) Danny Dietz, Sonar Technician 2nd Class (SEAL) Matthew Axelson and Hospital Corpsman 2nd Class (SEAL) Marcus Luttrell had a vital task. The four SEALs were scouting Ahmad Shah - a terrorist in his mid-30s who grew up in the adjacent mountains just to the south.

Under the assumed name Muhammad Ismail, Shah led a guerrilla group known to locals as the "Mountain Tigers" that had aligned with the Taliban and other militant groups close to the Pakistani border. The SEAL mission was compromised when the team was spotted by local nationals, who presumably reported its presence and location to the Taliban.

A fierce firefight erupted between the four SEALs and a much larger enemy force of more than 50 anti-coalition militia. The enemy had the SEALs outnumbered. They also had terrain advantage. They launched a well-organized, three-sided attack on the SEALs. The firefight continued relentlessly as the overwhelming militia forced the team deeper into a ravine.

Trying to reach safety, the four men, now each wounded, began bounding down the mountain's steep sides, making leaps of 20 to 30 feet.

Approximately 45 minutes into the fight, pinned down by overwhelming forces, Dietz, the communications petty officer, sought open air to place a distress call back to the base. But before he could, he was shot in the hand, the blast shattering his thumb.

Despite the intensity of the firefight and suffering grave gunshot wounds himself, Murphy is credited with risking his own life to save the lives of his teammates. Murphy, intent on making contact with headquarters, but realizing this would be impossible in the extreme terrain where they were fighting, unhesitatingly and with complete disregard for his own life moved into the open, where he could gain a better position to transmit a call to get help for his men.

Moving away from the protective mountain rocks, he knowingly exposed himself to increased enemy gunfire. This deliberate and heroic act deprived him of cover and made him a target for the enemy. While continuing to be fired upon, Murphy made contact with the SOF Quick

Reaction Force at Bagram Air Base and requested assistance. He calmly provided his unit's location and the size of the enemy force while requesting immediate support for his team. At one point he was shot in the back causing him to drop the transmitter. Murphy picked it back up, completed the call and continued firing at the enemy who was closing in. Severely wounded, Lt. Murphy returned to his cover position with his men and continued the battle.

An MH-47 Chinook helicopter, with eight additional SEALs and eight Army Night Stalkers aboard, was sent in as part of an extraction mission to pull out the four embattled SEALs. The MH-47 was escorted by heavily-armored, Army attack helicopters. Entering a hot combat zone, attack helicopters are used initially to neutralize the enemy and make it safer for the lightly-armored, personnel-transport helicopter to insert.

The heavy weight of the attack helicopters slowed the formation's advance prompting the MH-47 to outrun their armored escort. They knew the tremendous risk going into an active enemy area in daylight, without their attack support, and without the cover of night. Risk would, of course, be minimized if they put the helicopter down in a safe zone. But knowing that their warrior brothers were shot, surrounded and severely wounded, the rescue team opted to directly enter the oncoming battle in hopes of landing on brutally hazardous terrain.

As the Chinook raced to the battle, a rocket-propelled grenade struck the helicopter, killing all 16 men aboard.

On the ground and nearly out of ammunition, the four SEALs, Murphy, Luttrell, Dietz and Axelson, continued the fight. By the end of the two-hour gunfight that careened through the hills and over cliffs, Murphy, Axelson and Dietz had been killed. An estimated 35 Taliban were also dead.

The fourth SEAL, Luttrell, was blasted over a ridge by a rocket propelled grenade and was knocked unconscious. Regaining consciousness some time later, Luttrell managed to escape - badly injured - and slowly crawl away down the side of a cliff. Dehydrated, with a bullet wound to one leg, shrapnel embedded in both legs, three vertebrae cracked; the situation for Luttrell was grim. Rescue helicopters were sent in, but he was too weak and injured to make contact. Traveling seven miles on foot he evaded the enemy for nearly a day. Gratefully, local nationals came to his aid, carrying him to a nearby village where they kept him for three days. The Taliban came to the village several times demanding that Luttrell be turned over to them.

The villagers refused. One of the villagers made his way to a Marine outpost with a note from Luttrell, and U.S. forces launched a massive operation that rescued him from enemy territory on July 2.

By his undaunted courage, intrepid fighting spirit and inspirational devotion to his men in the face of certain death, Lt. Murphy was able to relay the position of his unit, an act that ultimately led to the rescue of Luttrell and the recovery of the remains of the three who were killed in the battle.

This was the worst single-day U.S. Forces death toll since Operation Enduring Freedom began nearly six years ago. It was the single largest loss of life for Naval Special Warfare since World War II.



If I may clarify points raised from the Washington Times' Rowan Scarborough to Ken McGraw, SOCOM.

As the senior Technical Advisor and Department head, it is my function to coordinate with the Film company and and DoD as well as oversee technical consulting services for the production company.

The advisory function for this film fell within four categories:

- Script review and vetting
- Production Department Consulting
- Talent Training
- On Set Coaching

Script Approval - as you know, effected services have had an opportunity through Phil Strub's office to review the script, and require edits, prior to approval as deemed necessary, in part, for compliance with image of service and OPSEC.

Production Departments - Property and Armorer, Wardrobe, and Art Department were provided with technical advice in order to accurately replicate environmental conditions and unclassified weapons and equipment as portrayed in the script as approved in the Production Assist Agreement. Former SEAL Mitch Hall, Markus Luttrell, and SOC Raymond Mendoza contributed the

majority of technical expertise during the prep. stage. SOC Mendoza, a close friend and teammate of Luttrell's was only intermittently present on leave during the prep phase. Under no conditions were classified TTP discussed or shown.

Talent Training - The director requested an abbreviated Weapons and Tactics, Land Warfare, course be given to Mark Wahlberg playing Marcus Luttrell; Taylor Kitsch playing Mike Murphy, Emile Hirsch playing Danny Dietz, and Ben Foster playing Matt Axelson.
